This Privacy Policy sets out the basis by which the Society processes your personal data.

Data Controller

Exmoor Natural History Society (ENHS), registered charity no. 1108445, is the 'Data Controller' for the purposes of the new General Data Protection Regulation ('GDPR') which becomes effective on 25 May 2018 with the aim of giving individuals control on personal data held about them.

Storage and processing of your membership information

ENHS will store your membership information securely on the Society's membership database (Access data base) and may use your information in the following ways:

- To record your title, name(s), addresses, phone number, joining date and, if appropriate, e-mail, Gift Aid declaration date, joining date, and bank records where needed for Standing Orders;
- To process your membership payment each year and if appropriate, to issue reminders
- To process your Gift Aid payment every year , if applicable;
- To send you news and information of events and activities and the magazine Exmoor Naturalist;
- To send information to Sponsors of Nest Boxes
- To update your information.
- We would prefer members, when possible, to send us their wildlife records via our Online Recording System (ORS) and if you can comply with this, please contact our IT assistant Carl Reading records@enhs.org.uk who will send you a password. However, if you do not have a computer and prefer to send us your written reports on paper or by email, these are welcome and should go to our Secretary carol@enhs.org.uk (C. Giddens, 12 King George Rd., Minehead TA24 5JD. Please be aware that written/e-mail records will be added to ORS and all go to the Somerset Environmental Records Centre and our own Recorders. Your name (but not your address) will be stored on ORS against any wildlife records submitted.
